SMS Messaging Terms & Compliance

1. **Program Description:** This messaging program sends information to customers who have explicitly opted in to receive SMS notifications. Opt-in is collected via web forms with a dedicated checkbox for SMS consent. Messages include customer support communications and program information.
2. **Cancellation Instructions:** You can cancel the SMS service at any time. Simply text "STOP" to the same number that sent you messages. Upon sending "STOP," we will confirm your unsubscribe status via SMS. Following this confirmation, you will no longer receive SMS messages from us. To rejoin, sign up as you did initially, and we will resume sending SMS messages to you.
3. **Support Information:** If you experience issues with the messaging program, reply with the keyword "HELP" for more assistance, or reach out directly to info@salts.ca or call 250-383-6811 during business hours.
4. **Carrier Liability:** Carriers are not liable for delayed or undelivered messages.
5. **Message & Data Rates:** Message and data rates may apply for messages sent to you from us and to us from you. Message frequency varies based on your service usage. For questions about your text plan or data plan, contact your wireless provider.
6. **Age Restriction:** You must be 18 years or older to participate in our SMS program.
